## MANUSCRIPT PREPARATION

The manuscript should be prepared in accordance with the <u>article preparation guidelines</u> (<u>http://journals.nstu.ru/machine-building/rules</u>) using MS Word text editor and attached as a file of \*.doc, or \*.docx type.

Scanned copy of the license agreement with the authors signatures and the experts' opinion (color scan, resolution not less than 300 dpi) should also be sent as \*.pdf, \*.jpg or \*.jpeg files using the personal account and section «Submit a paper».

Please note that authors should send a further request for participation, which indicate the full name (first name and last name), position, academic degree, title, subject matter of the report (Innovative technologies in mechanical engineering; Technological equipment, accessories and tools; Materials Science in mechanical engineering; Economics and organization of innovation processes in mechanical engineering), company name, address, phone, fax, e-mail, the necessity of a hotel. The application can be sent to the following e-mail: machine-building@mail.ru, metal\_working@mail.ru, or write "Message" in your authors' profile.

### RULES OF MATERIALS PREPARATION

# Paper Submission guidelines (http://journals.nstu.ru/machine-building/rules)

The text typed in Microsoft Word. Size of the originals - A4. Font - Times New Roman, font size of the main text - 14 pt, page setup - all fields 2 cm. Full justification. Line spacing one and a half. Indention - 1.25 cm. syllabification turned on. The illustrations, charts, graphs, photos should be clear and understandable, may be included in the text.

# Scientific publication should have the following structure:

- 1. **Title** (should be as short as possible and reflect the content of the text).
- 2. Abstract:
- in *Russian* based on GOST 7.9-95 a concise overview of the content of the article (according to GOST at least 10 lines, 850 characters), indicates the key issues on the approach to these problems and to achieve work; should use relevant words from the text of the article;
- in *English* should be more then in Russian and include 150-250 words, it is recommended to follow the chronology of the article, to use an English-language -specific terminology, not to include irrelevant details and use active rather than passive voice, avoid complex grammatical constructions (not applicable in scientific English).
  - 3. **Keywords** (should display the contents of the article).
- 4. Introduction (1-2 pages, a brief overview on the state of the problem with quotations or references to relevant literature. In the end of this section it is necessary to formulate a goal or task of the new study and how you did it).
- 5. **Theory** (for *theoretical work*) or **method of experimental studies** (for *experimental work*). Avoid repetition, excessive detail and known locations, detailed findings of formulas and equations (only the final result of the formula, explaining how they were obtained).
  - 6. Results and discussion.
  - 7. **Conclusions** (based on the work described in this paper, should be concise).

# **Brief requirements to the manuscripts**

**Physical units**. During preparing the manuscript one should be guided by the International System of Units (SI).

**Tables** are numbered if their number is more than one. Title is required when the table has an independent value, without the title are tables of auxiliary character.

**Mathematical formulas**. Complex and multi-line formulas should be typed entirely in the formula editor Microsoft Equation 3.0. Use only continuous numbering.

**Figures**. Recommended sizes of figures:  $60 \times 150$ ,  $60 \times 70$  mm. (300 dpi.)

**Bibliography** compiled in the course of literature references in the text and listed at the end of the manuscript. **References** cited in the text are given in square brackets, for example [1], [2, 3], [4-7], [4, pp. 23-28].



# An example of a Author Publishing Agreement

## **Author Publishing Agreement**

for the publication of the manuscript "The choice of the design parameters of the basic details on the drawing-board stage" (authors V. Ivanov, V. Petrov, ...) in the proceedings of the international conference "Actual problems in machine building".

1. The Author from the moment of the Agreement conclusion transfers to the Publisher on a grant basis the exclusive rights comprised in the copyright of the manuscript (the "Article"), approved and accepted for publishing by editorial board of the proceedings of the international conference "Actual problems in machine building" (the "Proceedings") till the publication of the Authors' Article in the Proceedings in print or electronic format and its' use and dessimination on a subscription basis or order on the territory of Russian Federation and all the world.

# 2. In accordance with this Agreement the right to use the Article, provided to the Publisher by the Author, include:

- 2.1. Announcement (preannouncement or public announcement of information on the Article), annotating (abstract of the content and other related information) and advertising of the Article in Proceedings and other media, including the publication of extracts from the Article at the expense of the Publisher;
- 2.2. Using the Article in electronic (digital) form in the Publishers' data bases, including NSTU electronic-library system, including Internet network with free or limited access.

#### 3. The Author guarantees the following:

- 3.1. The manuscript is the original work of the Author and co-authors (if there are any) and has never been published as submitted;
- 3.2.He/she has the consent of all co-authors of the Article, which publishing and distributing rights are transferring to the Publisher hereunder;
- 3.3. He/she did not publish the Article in the volume of more than 50% in other printed and (or) the electronic media, in addition to the publication of the Article in the form of a preprint;
- 3.4. This Article contains all statutory copyright links to cited Authors and (or) the publications, as well as used in this Article results and facts obtained by other Authors or organizations;
- 3.5. The Article does not include materials that can not be published in the press, in line with current regulations.

#### 4. The Author undertakes the following:

- 4.1. Insert the corrections, recommended by the reviewers and adopted by the Editorial board, in the text of the Article;
- 4.2. Read the proofs of the Article within the time limit prescribed by the release Schedule of the Proceedings;
- 4.3. Not to publish the Article in the amount of more than 50% in other printed and (or) electronic media before the publication of the Article in the Proceedings;
- 4.4. Submit original Article in in soft or hard copy, but in the absence of such opportunities in a manner consistent with the Editorial Board:
- 4.5. Contribute to proofread Article only the minimum changes, which is associated with the necessary corrections made in the original Article mistakes and (or) making factual changes;
- 4.6.Not to use for commercial purposes and in other publications electronic make-up page of the Article prepared by the Publishers without permission of the Publisher, in the case of transmission to the Author.

#### 5. The Publisher undertakes the following:

- 5.1.At its own cost and expense to provide the Article reviewing, scientific, literary, artistic and technical editing, production and (or) processing of illustrative material, the production of paper and electronic make-up page, graphic printing of the Proceedings containing the Authors' Article and its' dissemination under the terms of this Agreement and also holding a subscription campaign and collecting bids for the circulation of the Proceedings including promotion support;
